

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.orangeblossommedical.com](http://www.orangeblossommedical.com), and Orange Blossom Medical LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Orange Blossom Medical LLC include [www.orangeblossommedical.com](http://www.orangeblossommedical.com) and Orange Blossom Medical. The Orange Blossom Medical website is a medical practice site. By using the Orange Blossom Medical website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Orange Blossom Medical may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Orange Blossom Medical's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ## Use of your Personal Information

## Sharing Information with Third Parties

Orange Blossom Medical does not sell, rent or lease its customer lists to third parties.

Orange Blossom Medical may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third

parties are prohibited from using your personal information except to provide these services to Orange Blossom Medical, and they are required to maintain the confidentiality of your information.

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**
